#### **National Support Initiatives**

Initiatives that support sustainable urban development efforts through funding mechanisms from a nationwide stakeholder (e.g. ministries, foundations, agencies) to local level stakeholders, such as municipalities. The funding may encourage or lead to partnership networks and multilevel collaboration that enhances local level efforts in achieving national sustainable urban development targets.



#### Research questions

- What needs exist in border towns and cities for national support to urban – urban development across borders?
- What coordination efforts (horizontal and vertical) (need to) exist to achieve sustainable and green urban development in Nordic cross border towns and cities?
- What policy recommendations can we discern from the existing needs in border municipalities?


### Methodology



### Haparanda (SE) - Tornio (FI)


- International twin city

### Haparanda (SE) – Tornio (FI)




- Many problems solved over the years and high level of integration
- Common border coordinator for both municipalities
- Regular meetings between the municipality's officials and staff
- Challenges
  - Bus/taxis can't pick up passenger crossborder
  - Expensive to operate train across border
  - Health system



Halden (NO) – Strömstad / Dals-Ed (SE)

- Commuting despite distance
- *Svinesundskommittén* since 1980
  - Coordinates cross-border issues
  - Composed of municipality's politicians
  - Support from Region Västra Götaland and from Viken Region







Helsingborg (SE) – Helsingør (DK)


- Shortest link between Sweden and Denmark
